1. One pending application. Ron advised the ARB had just met and there was one approval.

President's Report:

1. Storm Drains – Ron Dinsmore would like to get a better idea of what the association is responsible for vs. the County. There was ensuing conversation regarding the cleaning out of the drainage between the ponds as being the responsibility of the association.

2. Street Lights – Board would like to add additional street lights as funds become available.
